We are excited to let you know about a new program we've introduced to our office, **PatientSERV**, which will help you cover the costs of uninsured services in a hassle-free and efficient manner. We are moving to this new program to give our patients more options and better value.

The **PS365 plan is an optional annual fee plan** that covers the costs of most uninsured services for **one year**, and allows the office to maintain our focus of providing quality care (see full list of services for more details).

I believe that the PS365 program is fairly priced and have included subscription rates specifically for couples and families. I hope that you will seriously consider the benefits for both you and your family.

Of course, you may choose not to participate in the PS365 program. In this case, any uninsured services you receive will be charged on a Pay-As-You-Go basis. For this option, you may leave payment information safely and securely with PatientSERV that will only be charged when an uninsured service is provided.
