

Purchaser Licence Agreement

FHO+ RA Summary Tool

This agreement is between **Stewart Medicine Professional Corporation** ("Stewart Medicine") and the doctor named on page 2. Any corporation named there is also a purchaser. "You" means those purchasers. The "Tool" means the supplied FHO+ RA Summary Tool and included updates.

ONE DOCTOR. ONE OHIP BILLING NUMBER.

Your copy is programmed to analyze only the doctor's billing number entered on page 2. Delegated staff may use it solely for that doctor. This is not a clinic-wide or multi-doctor licence.

1. Your licence

After payment and delivery, you may use the delivered version indefinitely, subject to this agreement. The licence is non-exclusive and non-transferable. You may keep backups and use it on multiple computers. Delegated employees or billing staff must follow these terms; you are responsible for their access and use. A separate licence is required for each other doctor.

2. No sharing, alteration or circumvention

- Do not share, lend, sell, sublicense, publish or distribute the Tool or give access to it, except to staff permitted under section 1.
- Do not modify, hack, reverse engineer or create derivative versions; bypass or disable the billing-number restriction; or remove licence, identity or ownership notices. Do not use AI or another person to do these things.
- These restrictions cover the original Tool, its code, copies, extracted code and modified or derivative versions, except to the extent a restriction is prohibited by law. No ownership of the Tool or its intellectual property is transferred.

3. Price and included updates

One-time fee: \$149 + applicable HST. No subscription. Minor updates released within six months after payment and initial delivery are included. These are bug fixes and small improvements, not major upgrades or new paid modules. Later updates cost extra unless agreed otherwise. No particular new feature or release schedule is promised.

4. Final sale

The sale is final and non-refundable, subject to the functionality guarantee in section 6 and rights that cannot legally be excluded. Delivered digital copies cannot reliably be recalled or their continued use prevented. Changing your mind or not using the Tool does not qualify for a refund.

5. Agreement terms

Ontario law and applicable Canadian law govern. These two pages are the entire licence agreement; changes require written agreement. An unenforceable term does not invalidate the rest. Signing and Stewart Medicine's acceptance by delivery after payment form the agreement. Electronic signatures are accepted.

Guarantee, responsibilities and acceptance

6. Functionality guarantee

Stewart Medicine guarantees that the unmodified Tool will materially perform its described summary and audit functions with supported individual-physician MCEDT RA files and a desktop Chrome version current at delivery. Email any material fault to the contact below. Stewart Medicine will provide assistance and repair the fault or provide a working replacement at no charge within a reasonable time. Later changes to OHIP formats or browsers are covered only if addressed by an included update. This guarantee is not a promise of error-free results or additional OHIP payments.

7. Your records and privacy

Check results and possible omissions against your records before acting. You remain responsible for billing decisions and deadlines. The Tool is not medical, legal, tax or accounting advice and is not endorsed by OHIP. Files are processed locally; you control access, secure storage and backups. Do not send patient information for support. You may lawfully use and share generated reports; the software restrictions do not prohibit that.

8. Liability and ending the licence

To the extent permitted by law, Stewart Medicine is not liable for indirect or consequential loss, and its total liability is limited to the licence fee paid. This does not limit the repair/replacement guarantee, liability for fraud or wilful misconduct, or rights that cannot be excluded. A material breach may end the licence after written notice and 10 days to correct it; unauthorized distribution or circumvention permits immediate termination. On termination, stop using and delete the Tool and its copies. You may retain your data and generated reports.
